Communication is extremely important in these times of uncertainty. Together we can keep each other safe. Together we provide a safe educational program for your child. Elwyn is committed to staying informed and following the guidelines from the state and CDC as we move forward with the 2020-2021 school year.

In order to ensure continuation of services during the Coronavirus Pandemic, a detailed Health and Safety Action Plan was developed based on the federal, state, and CDC guidance. We are considering both center based and community based services, and have been working to ensure that parents have both face-to-face and/or virtual learning options, as appropriate.

Tele-intervention Many of our families are already participating in Teleintervention services, and we've heard lots of very positive feedback.
